PhD Project Description:

The Graduate School is a joint project of Freie Universität Berlin, Humboldt-Universität zu Berlin, and Leibniz-Zentrum Moderner Orient, which brings together scholars in the humanities, social sciences, and area studies. It investigates the plurality, changeability, and global connectedness of Muslim cultures and communities in the Middle East, Asia, Africa, Europe, and North America, with a focus on strategies of negotiating diversity, difference, and distinction, both among Muslims and between Muslims and non-Muslims. Our Graduate School offers a structured, research-oriented training programme based on the principle of discipline-based multidisciplinary.

The Berlin Graduate School Muslim Cultures and Societies examines, in a systematic and comparative way, texts, objects, and practices variously understood as Islamic. Special attention is given to strategies of dealing with diversity, difference, and distinction, among Muslims as well as between Muslims and non-Muslims. This includes negotiating plurality and pluralism, making our research programme deeply relevant to scholarly interests as well as pressing societal concerns in both Muslim and non-Muslim contexts. The area of study ranges from the Middle East, Africa, and Asia to Europe and North America.

We foster a culture of discipline-based multidisciplinary, which is based on close interaction between scholars from the humanities, social sciences, and area studies. This includes Arabic Studies, Art History, Central Asian Studies, History, Human Geography, Islamic Studies,

Political Science, Semitic Studies, Social and Cultural Anthropology, South Asian Studies, Southeast Asian Studies, Southeast European History, and Turkic Studies. The Graduate School can build upon a well-established and successful history of collaboration among the principal investigators, who come from various disciplines and institutions and can offer doctoral candidates opportunities to build up additional research contexts at the national and the international levels.

Language Requirements:

As **English** is the primary language of communication at BGSMCS, you are expected to have advanced English-language proficiency. Please hand in one of the following certificates as proof of proficiency in English:

- ETS TOEFL certificate (minimum score of 600 for the paper-based test, 250 for the computer-based test and 100 for the internet-based test)
- Cambridge Certificate of Proficiency in English, CPE (any grade)
- Cambridge Certificate in Advanced English, CAE (grade A or B)
- IELTS test (level 7.0)

In addition, we ask you to list the **language(s) relevant to your dissertation project** (e.g. Arabic, Turkish, Urdu etc.). As proof of your proficiency, you may hand in a transcript of records from your university, a certificate from a language school or the like.

Academic Requirements:

The formal prerequisite for application to the programme is a university honors degree reflecting a level of attainment that is above average (typically an M.A., or diploma degree, with a grade of “very good”; with ranking, where applicable). A Bachelor’s degree is not sufficient. The degree should be in one of the disciplines represented at the Graduate School (Arabic Studies, Art History, Central Asian Studies, History, Human Geography, Islamic Studies, Political Science, Semitic Studies, Social and Cultural Anthropology, South Asian Studies, Southeast Asian Studies, Southeast European History, and Turkic Studies). Candidates are expected to submit an outline of their proposed dissertation project (maximum 6 pages, with a summary of no more than half a page), to include a short description of the topic, the current state of research, and its theoretical and methodological orientation, as well as a preliminary work schedule and an indication of whether the work is to be conducted via archival or field research.

As English will be the primary language of communication, students are expected to have advanced English-language proficiency. In addition, students must demonstrate proficiency in the language(s) relevant to their projects. It is assumed that language skills can be improved over the course of the doctoral programme.
