Due Notice of Legal Rights and Remedies

Pursuant to Section 14.4 FU-WahlO any eligible voter may submit objections to the decision to include (or not include) a nominated individual on the ballot to the Central Election Board within three days after the list of official candidates has been published. The deadline to submit objections expires at noon (12:00) on the third day following publication of the list. The Central Election Board shall make the final decision concerning any such objections, which are to be submitted in writing together with a statement of compelling reasons to the Central Election Board, Rudeloffweg 25/27, 14195 Berlin. To the extent that the grounds for objection are not immediately obvious, the person raising the objection is obliged to present the necessary documentation to substantiate their claim by the end of the period during which objections to the list of official candidates may be raised.
